## C. Ongoing Business

### A. City Updates

Michael introduces City Communications Manager Julie Brechbill. Julie shared updates on the city website, confirming a focus on a more robust and accessible representation of city parks and greenspaces on the refreshed site. Julie also noted that city signage is being reviewed and assessed for rebranding, more consistent branding, and that currently parks and trails signage would be under that review. When Tixie asked about incorporating GDOT signage as well, Julie suggested that PG&T take that up with Len Housley and David Versel.

**ACTION ITEM:** Motion to direct PG&T to map recommended locations for signage placement and to research any applicable laws, regulations, or standards regarding the type of directional signage to be used.

Scott and Michael agreed to work together on development of signage map.

Michael reported no further movement on city negotiations with church to purchase parcels expanding Johnson Dean.

Regarding updates on the city parking lot, Michael reported Columbia Engineering is finishing construction plans for bidding, and Council approved a \$2.8M construction budget.

### **B. Developer Checklist**

Tixie introduced Robert Forro and asked him to lead discussion regarding next steps for addressing the Board's interest in developing a process check-list for ensuring permitting and construction protocols are consistently addressed by City Staff and developers, as well as making recommendations for more robust BMP's relevant to stormwater management. Robert noted the city already has a checklist, and while it could be improved, he questioned the concern that Norcross has a stormwater management problem. Instead, Robert recommended the Board consider the following:

- a. PG&T shifts focus to public outreach to educate citizens and elected officials on the importance of innovative urban stormwater mitigation.
- b. Research urban stormwater mitigation models that work and share with staff and Council.
- c. Identify key (current) development ordinances that are counter-productive to supporting green infrastructure, such as current ordinances prohibiting bioswales, low-profile curbs, etc.)
- d. Encourage staff and Council to consider Norcross Builders' Group as key community stakeholders and include them in relevant discussions.
- e. Activate nature-based programming as a way to build emotional connection between citizens and local parks.

**ACTION ITEM:** Motion to remove the Developer Checklist Project from the table and cancel the vote pending further research and consideration of Robert Forro's suggestions.
