3. Ongoing Business

A. Council Update - (Councilman Bruce Gaynor)

Gaynor absent, no report submitted.

B. Tree Preservation Board Update - (Terry Sutton)

Terry shared TPB's discussion re purchasing approximately 3 acres of land adjacent to Johnson Dean Forest Preserve and currently owned by Christ Church Episcopal. He reported that City Parks & Utilities Director Len Housley had attended a meeting with key Church stakeholders to discuss and that Len had informed the Church that the City - if it were to make an offer on the land (not confirmed that they will) would only consider offering appraised value of land. Len agreed to securing a survey of the parcels being considered and an appraisal of that land's current market value. PG&T noted that the proposed parcels do not result in connection from Barton St to Holcomb Bridge.

Terry also reported TPB's findings that City of Norcross' total tree canopy has been reduced by 22 acres in the past 18 - 24 months.

C. RFP for Piedmont Pathway Concept Report Update (Michael Jones)

Michael report Norcross City Council had approved the contractor selected to conduct the Piedmont Pathway Feasibility Study and a contract had been signed. Michael invited PGT to attend the project kickoff meeting (date and time to be determined) - Tixie, Scott and Jon said they would like to attend.

D. New Projects Planning

Commission members brainstormed ideas for strategies addressing selected strategies outlined in the PGT&GI Master Plan and self-assigned projects they will lead in collaboration with other PGT members, City staff and other local stakeholders (including other City volunteer boards.) Projects identified are as follows:

Kassie - Collaborating with Michael Jones to develop proposal for subcontracted youth programming in Norcross Parks for 2026. Kassie also agreed to write an article re group rides with students to school for submission to City of Norcross newsletter on behalf of PG&T.

Scott - collaborating with Norcross Sustainability Manager Jalia Killings to expand existing bike route for Pedal Norcross (October 18, 2025) and plan a table display promoting PG&T outreach initiatives such as surveying bikers for feedback on expanded route and additional feedback re biking in Norcross.

5. **Additional Input/Discussion Not Otherwise Addressed By This Agenda**

Scott reported meeting with Norcross Sustainability Manager Jalia Killings regarding his proposed bike route extension and shared the following outcomes:

- Jalia supported Scott's ideas for extending the annual bike route cycled at Pedal Norcross event, and agreed to meet with Norcross Police Chief to confirm feasibility of extended route. Scott reminded PG&T that the proposed route does not include bike trails east of Buford Hwy, noting that routes in this area will be addressed by both the Norcross Greenway and future Piedmont Pathway, and that connection from Historic Norcross to these futures projects is considered in his vision for expanding bike routes throughout the community.
- Jalia is reportedly checking into the status of Norcross' "Vision Zero" study and verify the parameters of the study area. She plans to share the City's proposed future bike routes and pedestrian paths (including new greenway) at Pedal Norcross.
